MEMBERSHIP CLASSIFICATION RATES, & PAYMENT OPTIONS

Regular Individual Membership - \$900.00

Persons thirty-five (35) years old or older who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

Regular Family Membership - \$1150.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

Student Member (High School) - \$300.00

Youth, seventeen (17) years of age or younger who are not dependents of a current member may purchase an annual High School Student Membership for a calendar year.

Student Member (College) - \$450.00

Individuals, twenty-four (24) years of age or younger and who are enrolled full time in a Trade School, College, or University may purchase an annual College Student Membership. Full time enrollment is at least twelve (12) hours or more per semester. Proof of enrollment is a requirement at the beginning of each golfing season.

Individual Under 35 Memberships - \$700.00

Persons under the age of thirty-five (35) years old who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

Family Under 35 Memberships - \$950.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this Membership the oldest adult must be under the age of thirty-five(35)

First Time Half-Off Regular Individual Membership - \$450.00

Persons eighteen (18) years old who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this you must be a first time ever member.

There will also be a **\$100 administration fee** to get you into our system.

First Time Half-Off Regular Family Membership - \$575.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this you must be a first time ever member.

There will also be a **\$100 administration fee** to get you into our system.

Annual Golf Cart Rental – (1) PCC Cart = \$450.00

As an *Annual Golf Cart Renter*, you will have unlimited use of *One (1)* golf cart, two riders, per day, all day.

If you need a second cart, the golf shop will rent an addition golf cart on a first-come, first-serve basis. Must be 16yrs old with valid driver license to operate any PCC Cart on the course.

Private / Personal Sheds:

On Premise – Usage Fees for Personal Golf Carts Stored on Club Property - \$150.00 (Trail Fee)

Off Premise – Usage Fees for Personal Golf Carts - \$125.00 (Trail Fee)

Personal Shed or G/H Shed Fee (Metal or Wooden) - \$500.00

Membership Payment Options:

- A. Payment in Full on or before February 9th, 2025 (*Super Bowl Sunday*)
Entitles Renewing Members to a \$50 credit in your PCC Account. (Excluding Student Memberships)
(Certificates may not be used towards membership dues or tournament entry fees.)
- B. Payment in Full After February 9th, 2025 and must be paid prior to League Start Date & Participation.
- C. A Payment Plan can be made for any other form of memberships typically in a 4-5month block. Talk with the Clubhouse Manager on these options. (All Payments will be charged on the 15th of the Month.)
 - a. Monthly Payment Plan: *Regular Individual Membership* broken out Monthly plus a \$25 service charge with first Payment.
 - b. Monthly Payment Plan: *Regular Family Membership* broken out Monthly plus a \$25 service charge with first Payment.
 - c. Monthly Payment Plan: Cart Rental, Monthly charge will be added onto your monthly dues.
